We believe the best opportunities exist in areas of the market that are the most inefficient.

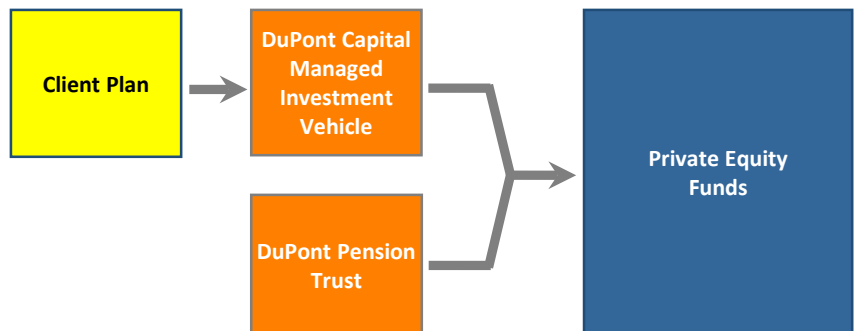
- ❖ We allocate to private equity funds that invest in small to mid-sized companies.

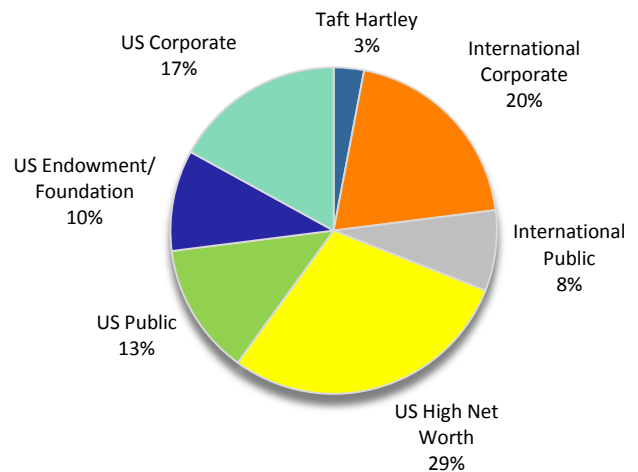
